## Greetings, and best wishes for a blessed 2022

- 1. In less than a week, we will gather for our 2021 Annual Meeting, on January 13-15, 2022: "Orthodoxy in a Pluralistic World." This promises to be an enriching meeting, with an outstanding slate of presentations and panels, and distinguished presenters. If you have already registered, you will receive your zoom link a few days in advance of the meeting. All attendees must register. Registration is free to members current in their 2021 dues (which can also be paid when you register, if necessary).

There are panels dealing with ecumenical issues, others taking on modern science and our Orthodox faith, and still others that look to the ways people struggle with having faith in the modern world or how to practice that faith today. - 3. The Florovsky Lecture, "'Preserving the Fullness of Thy Church': Fighting Fundamentalism, Defending Dialogue and Reclaiming Catholicity" is offered this year by the Very Rev. Dr. John J. Jillions. The lecture, held in conjunction with the OTSA annual meeting, will be on Friday evening, January 14, 2022, from 7:30-9:00 pm (EST). Attached to this email is the flier for the lecture.   - b. A proposal that our next annual meeting be held in conjunction with the quadrennial IOTA conference planned for January 2023 in Volos, Greece.
